THE V.C. AND G.C. REUNION IN LONDON - NOVEMBER, 1983

The New Zealand Contingent for the Reunion arrived in London on 29th September. The New Zealand Government were kind enough to give the members and their wives a free ticket. Air New Zealand did the rest, looking after the party very well indeed. N.Z. was represented by Jack Hinton, Charles Upham, L.H. Trent and Keith Elliott and we were pleased indeed Mrs. C. Hulme, widow of Sgt. Clive Hulme, was included in the invitation. We were sorry that the 1914-18 V.C. Matt. Laurent of Hastings and his wife were not able to travel with us but age catches up with old Soldiers and their wives who really make the show.

The Reunion was very low key. We did not parade or lay a wreath at the Cenotaph at Westminster, our first engagement being a church service at St.Martins in the Field, in Trafalgar Square. This was a thanksgiving service and very impressive indeed. The next gathering was held at the Chelsea Barracks, where we met many of the Old Soldiers who live in this glorious haven.

The main gathering for all members of the Reunion, wives, relatives and friends was held at The Fishmongers Hall in London. Margaret Thatcher the Prime Minister was the guest of honour. She was very gracious and chatted freely with all present. We had a very interesting trip to the British Army Museum in London. From France 1914-18 to the Falklands 1982, all the changes in Army equipment and modern methods used in warfare were on show. Talking to one of the personnel responsible for setting up the Museum, he told me that they had visited the War Museum at Waiouru in N.Z. and gleaned some of their ideas from the exhibits there.

The V.C. and G.C. Reunion Dinner was held in Cafe Royal in London. The speaker was Prince Andrew, who spoke very well indeed and included some of his first hand experiences while fighting in the Falklands, something which he will never forget as he was actually in combat.

The New Zealand Contingent were given a reception at New Zealand House. The Honourable Bill Young, High Commissioner for New Zealand, spoke very kindly, not only from the point of view of New Zealand's Representative in London, but as a soldier who served his country in 1939-45. Rear-Admiral Place, President of The Victoria Cross/George Cross Association was present. Altogether a very happy and successful party. The Hon. Bill Young was invited to the V.C./G.C. Dinner, which we thought was very fitting.

We were fortunate indeed to experience such good weather while in London and to meet V.C./G.C. winners from all over the world was really a great experience. The trip was only made possible by the New Zealand Government and all members of the N.Z. Contingent were most grateful.

We made our own way home, visiting different places en-route and taking our time made this Reunion a memorable one for us all. V.C's are a dying race; it is very assuring to know that the G.C. winners will be able to carry the Spirit of these Reunions of Members of the Commonwealth on from one generation to another.

TREASURER'S REPORT

The financial year just ended is the first in which we have paid our subscriptions at the higher rate of \$4 per member and the effect of this increase is shown in the Income and Expenditure Account included in this issue of the Newsletter.

About 160 members of the Branch pay their subs. in any one year but those who forget to send in their subs. one year often make up for it the following year and, every now and then, we receive a donation in place of past subs. unpaid.

Also, we continue to receive many donations to the Branch Welfare Fund and other donations for general purposes and these donations add up to a fair sum in the course of a year. For the second year running, the Welfare Fund has been credited with more in donations than it was necessary to pay out, leaving a credit balance of over \$600 in this fund at the end of the year. The need for Welfare assistance is likely to increase, so it is good to have a reasonably healthy balance in this fund. The Committee thanks all those who have sent in donations, large or small, during the past year.

Expenditure: The cost of printing and mailing these Newsletters is our only major item of expense and this cost is an increasing one, which is why the subs. were put up in 1983. For some years now, the work of typing the copy, addressing the envelopes, folding, etc. has been done without charge to the Branch by the staff of the Accountancy practice in which the Treasurer is a partner. But he is now but one of 3 partners in the firm and this work has to be charged for, as from this issue of the Newsletter. It is not going to cost that much but it will put the Branch's expenses up. There seems to be general agreement that the Newsletters are well worth what they cost and communications are the lifeblood of any organisation. You can be sure that we will do our best to keep all costs as low as possible.

Subscriptions Payments for 1984/85:- About 40 of our members have paid their subs. in advance for the financial year about to start. For the rest of us, March is the month for payment and, once again, we ask those unable to attend the Branch function on 11th March to use the reply slip in this issue to send in their 1984/85 subs. NOW. This will help to keep our costs down; it costs money to send out subscription accounts and we wish we didn't have to. Receipts will not be issued unless a stamped, addressed reply envelope is sent with the remittance.
